Planning and Building Director Matt Ziska presented the hiring of a part-time building inspector. This new part-time position was advertised in late June and July with local media, various code administration agencies, and on www.mokena.org. Thirty-three resumes were received in response to the advertisement. Following a thorough interview process, Ms. Duffin emerged as the candidate best suited to fill the position.

Ms. Duffin, a Mokena resident, possesses a Bachelor of Science degree in Mechanical Engineering from Penn State University and over 20 years' worth of experience as a fire code consultant. In more recent years, she has devoted her time fully to the needs of her growing family at home.

Ms. Duffin has accepted an offer to the fill the new part-time building inspector position pending the Board's formal ratification of her appointment this evening. She has successfully passed background checks and a pre-employment physical, and is prepared to begin her employment with the Village tomorrow (September 11).

Filling of this part-time building inspector position will greatly assist Mokena's Community Development Department in meeting growing community demands in the area of building code administration.
