Appointment of Kelly Huscher to Customer Service Representative Position

Finance Director Barb Damron presented a recommendation to appoint Kelly Huscher to the position of Customer Service Representative.

Ms. Huscher will be filling an open position in the Administrative Services/Public Works Departments. This position was advertised internally first. There was no interest from existing employees, so the position was advertised externally. The Village received approximately 55 resumes. The resumes were reviewed and candidates were then selected to be interviewed and tested.

As a result of the interviews and skills tests, it was determined that Kelly Huscher possessed the skills and qualities that would best benefit the Village for the Customer Service Representative position. Ms. Huscher is a resident of Mokena. She and her family have resided in Mokena for 16 years. Staff feels that she will be an immediate asset to the Village. Her knowledge and experience should blend well with the Village's existing needs.

Trustee Engler made a motion to approve the employment of Kelly Huscher to the position of Customer Service Representative at a Grade 1, Step 5 effective February 25, 2020. Trustee Siwinski seconded.

PRE-SCHEDULED PROPOSALS/PRESENTATIONS AND VISITORS Introduction of Patrol Officer Owen Price

Police Commander Chris Carlson introduced new patrol officer Owen Price to the Village Board and the public.

At the Board of Fire and Police Commission's December 5, 2019 meeting, Mr. Owen Price was issued a certificate of appointment for the position of patrol officer, with an effective date of February 3, 2020.

Officer Price had previously fulfilled the requirements of the Illinois Law Enforcement Training and Standards Board (ILETSB) for certification as a part-time police officer by completing the 560-hour Part-Time Basic Law Enforcement Academy (PTBLEA). He was subsequently hired in November 2018 by the Sheridan, IL Police Department as a full-time police officer, requiring that he complete an 80-hour transition course in order to fulfill the requirements of the ILETSB.

Officer Price began his field training on February 3rd. He is currently scheduled to attend the Suburban Law Enforcement Academy (SLEA) beginning March 30th. Upon graduating from the academy, he will complete his field training and will be eligible for solo patrol in mid-August.

Officer Price and his wife Breanna, who married in September 2019 are expecting their first child.

Officer Price thanked the Board for allowing him to work here.

Mayor Fleischer stated the Board supports the Village's police officers.
