Respect Life Week Proclamation

A proclamation was read by Clerk Martini proclaiming the week of October 3, 2021 as Respect Life Week in the Village of Mokena.

Mrs. Helen Sluis, on behalf of the St. Mary Council of Catholic Women, thanked Mayor Fleischer and the Village Board for the Respect Life Week Proclamation. She discussed the value of human life.

Appointment of Timothy Bershers to Wastewater Treatment Plant Mechanic Position

Director of Public Works Jim Kulesa stated that the Utilities Department currently has an opening for Wastewater Plant Mechanic position as a result of the retirement of Dan Manns in spring of 2021. Fifty-five (55) applicants submitted resumes and Village staff conducted initial phone interviews with fifteen (15) candidates. Village staff further conducted second-round interviews in person with eight (8) of the candidates. Final interviews were conducted with the three (3) candidates.

Director of Public Works Kulesa advised that based on the results of these interviews, as well as work experience and references, it was determined that Mr. Timothy Bershers was best suited to fill the Wastewater Plant Mechanic position for the Village of Mokena.

He further recommended the appointment of Tim Bershers to the position of Wastewater Plant Mechanic in the Public Works Department.

Trustee Engler made a motion to approve the appointment of Tim Bershers to the position of Wastewater Treatment Plant Mechanic in the Public Works Department at the starting step for that position in the First Amendment to the Collective Bargaining Agreement between the Village of Mokena and the International Union of Operating Engineers, Local 150, Public Employees Division, July 1, 2016 – June 30, 2020, executed March 22, 2021, with an effective date of October 4, 2021. Trustee Richmond seconded.
