Appointment of Trustee George Metanias as Mayor Pro Tem

Contract Extension for Brian Benton as Interim Chief of Police

Mayor Fleischer recommended a six-month contract extension for Interim Chief of Police Brian Benton.

Trustee Engler made a motion to approve a contract extension for Brian Benton as Interim Chief of Police effective February 27, 2022. Trustee Richmond seconded.

Introduction of Sergeant Stephen Chlebek

Interim Chief of Police Brian Benton advised that due to the recent retirement of Sergeant Michael Keller, there is a vacancy in the police department's staff for the position of Sergeant. Pursuant to Interim Chief Benton's request to the Board of Fire and Police Commisioners, Officer Stephen Chlebek was promoted to the rank of Police Sergeant on January 13, 2022.

Interim Chief Benton highlighted Officer Chlebek's educational background and tenure with the Mokena Police Department, stating he has worked as a Patrol Officer and Detective, trained as a Lead Homicide Investigator, Sexual Assault Investigator, served as a Field Training Officer and Evidence Technician, and is a member of the Illinois Law Enforcement Alarm System. Interim Chief Benton further announced numerous awards Officer Chlebek received during his career, including two Life-Saving awards, one Letter of Meritorious Duty, twenty-four Letters of Distinguished Duty and eleven Letters of Exceptional Duty.

Interim Chief Benton introduced Sergeant Stephen Chlebek to the Village Board and recited a recent Letter of Distinguished Duty. He congratulated Sergeant Chlebek on his promotion.

Sergeant Chlebek reaffirmed his dedication and commitment to the Village of Mokena. He thanked his family for their support and the Village Board for the opportunity.

Mayor Fleischer thanked Sergeant Chlebek for his time and service to the Village.

Appointment of Chief Building Inspector Candidate Krzystof Kociolek

Community & Economic Development Director Matt Ziska stated that due to his appointment and promotion to Community & Economic Development Director in April 2021, the Village Board authorized Staff to move forward with hiring a Chief Building Inspector. He advised the position was advertised in June 2021 and 123 applications were submitted in interest to the position.

Community & Economic Development Director Ziska informed the Board that 31 interviews were conducted. Upon conclusion of the interview process, it was determined that Mr. Krzystof Kociolek possessed the skills and qualifications necessary to fulfill the duties of Chief Building Inspector. He highlighted Mr. Kociolek's credentials, educational and career background, and recommended Mr. Kociolek's appointment to Chief Building Inspector.

Trustee Engler made a motion to appoint Kryzsztof Kociolek to the position of Chief Building Inspector for the Village of Mokena at an annual salary of Grade 17, Step 10a, effective January 25, 2022. Trustee Richmond seconded.

Appointment of Civil Engineer Candidate Kyle Vester

Director of Public Works Kulesa advised the Board that because of former Civil Engineer Brian Fei's departure from the Village and the promotion of Daniel Peloquin to Assistant Public Works Director, there are two vacancies in the Village for the position of Civil Engineer. He stated the position was advertised on multiple platforms and the Village received 33 applications in interest to the position.

Director of Public Works Kulesa discussed the interview process. Based on the results of the interviews and review of training, work experience, and references, it was determined Mr. Kyle Vester possessed the skills and capabilities necessary to perform all tasks required in connection with the Civil Engineer position. Director of Public Works Kulesa highlighted Mr. Vester's educational and career background, and recommended Mr. Vester's appointment to Civil Engineer.

Trustee Engler made a motion to appoint Mr. Kyle Vester to the position of Staff Civil Engineer in the Public Works Department for the Village of Mokena at an annual salary of Grade 17, Step 17a, effective January 25, 2022. Trustee Richmond seconded.
