APPOINTMENTS/PROCLAMATIONS/PRESENTATIONS

Appointment of Kevin Taylor to Maintenance I Worker Position

Assistant Director of Public Works Dan Peloquin advised the Board that as a result of Michael Lief's promotion in August 2022, there was a vacancy in the Street Department for a Maintenance Worker I position. The position was advertised in July 2022 and twenty-eight (28) applicants submitted resumes.

Assistant Director of Public Works Peloquin discussed the interview process. Based on the results of first and second round interviews, as well as a review of training, work experience, and references, it was determined that Kevin Taylor was most qualified to fill the vacant Maintenance Worker I position.

Assistant Director of Public Works Peloquin reviewed Mr. Taylor's municipal experience and qualifications. He further recommended the appointment of Mr. Taylor to the position of Maintenance Worker I in the Street Department as he possesses the skills and capabilities necessary to perform all tasks required in connection with the position.

Trustee Engler made a motion to approve the appointment of Kevin Taylor to the position of Maintenance Worker I in the Street Department at the starting step for that position in the First Amendment to the Collective Bargaining Agreement between the Village of Mokena and the International Union of Operating Engineers, Local 150, Public Employees Division, July 1, 2016-June 30, 2020, executed March 22, 2021, effective on approval with an effective start date August 23, 2022. Trustee Metanias seconded.

Trustee Metanias welcomed Mr. Taylor to the Village and complimented the support of the Public Works Department displayed at tonight's meeting.

Dixon Engineering Agreement; East Tower Painting Project

Assistant Director of Public Works Peloquin presented the recommendation of an agreement with Dixon Engineering to provide engineering and construction related services for the East Tower Painting Project.

Assistant Director of Public Works Peloquin advised that the services needed for this project are more extensive and specialized than the 187th Street Tank Repair and Repainting Project and include certified weld and coating inspections on the interior and the exterior of a 130-foot-high elevated tank. Dixon provided the pre-bid inspection, report, specifications, and bidding services for this project. He further recommended Dixon Engineering to provide this specialized work for the remainder of the project.

Trustee Engler made a motion to approve an agreement between the Village of Mokena and Dixon Engineering for engineering and construction related services for the East Tower Painting Project and to authorize the Village Administrator and Staff to execute same. Trustee Metanias seconded.



SiteOne Landscape; 8119 W. 189th Street: Special Use Permit Approval

About SiteOne:


- National wholesale distributor of landscape supplies for residential and commercial landscape professionals

Background:


- ▶ On June 20, 2022, the Village Board conceptually reviewed the proposed Special Use request and directed staff to forward it on to the Planning Commission for the required public hearing.
- ▶ On July 21, 2022, the Planning Commission conducted a public hearing and unanimously recommended Village Board approval. There were no comments from the public at that time.
- ▶ On August 8, 2022, the Village Board reviewed the draft terms of the Special Use Permit Ordinance unanimously directed Staff to prepare the final ordinance documents for approval.


Proposed Improvements: Current Photo Proposed Facade



Special Use Permit Ordinance:

- Owner agrees that neither it nor its respective purchasers, lessees, permitted successors or assigns shall designate an "order-acceptancepoint" other than the Village of Mokena for determining the municipal sales tax.
- Owner shall install winged-privacy slats providing a minimum of 90% coverage (opacity) within the chain link fence around the full perimeter of the outdoorstorage area.
- Owner agrees that no items shall be stored higher than the eight-foothigh chain-link fence.
- Owner agrees that no items shall be stored on the property outside of the enclosed storage area.
- Owner agrees to comply with Village of Mokena Business Regulations, Building Code Regulations, and Fire Code Regulations





Community and Economic Development Director Ziska informed the Board that Seth Campbell of ICT Capital, LLC, acting on behalf of SiteOne Landscape Supply, is seeking Village Board approval of a Special Use Permit Ordinance to allow outdoor storage for the bulk storage of landscape supplies at the property located at 8119 W. 189th Street. He reviewed the zoning of the property as I-1 Industrial. He advised that SiteOne Landscape Supply is a national wholesale distributor of landscape supplies for both residential and commercial landscape professionals, with over 590 locations in the country and ten (10) located in the Chicagoland area. Petitioners are planning to close their current location at 18801 S. Wolf Road in unincorporated Will County and relocate to the subject site.

Community and Economic Development Director Ziska provided a timeline of the Board's review of the Special Use Permit request. He discussed petitioner's proposed improvements including an updated exterior façade and the installation of winged privacy slats within the existing chain link fence to provide a minimum of 90% coverage per the

Village's screening standards. Petitioners also plan to install four (4) additional parkway trees along 189th Street and have agreed to repave and restripe the front parking lot.

Community and Economic Development Director Ziska highlighted notable sections of the proposed Special Use Permit including:

- Owner agrees that neither it nor its respective purchasers, lessees, permitted successors or assigns shall designate an "order-acceptance point" other than the Village of Mokena, Will County, Illinois, for determining the municipal sales tax.
- Owner shall install winged-privacy slats providing a minimum of 90% coverage (opacity) within the chain link fence around the full perimeter of the outdoor storage area.
- Owner agrees that no items shall be stored higher than the eight-foot-high chain link fence.
- Owner agrees that no items shall be stored on the property outside of the enclosed storage area.
- Owner agrees to comply with Village of Mokena Business Regulations, Building Code Regulations, and Fire Code Regulations.

Trustee Engler made a motion to adopt Ordinance No. 2022-O-014, an ordinance granting a Special Use Permit for the property located at 8119 W. 189th Street, and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.
