RECESS OF REGULAR SESSION

Mayor Fleischer called a recess at 6:52 p.m.

RECONVENE REGULAR SESSION

The regular session reconvened at 7:00 p.m.

Mayor Fleischer advised that the night's meeting began with executive session.

DISCOVER MOKENA

Charleigh Widleski was recognized for her participation and third place finish in the 2022 Major League Baseball (MLB) Pitch, Hit & Run competition. She thanked Mayor Fleischer, the Board of Trustees, and Trustee Dauphinais for their invitation to the night's Board meeting, and also thanked Village Administrator John Tomasoski and Assistant Village Administrator Kirk Zoellner for their involvement. She additionally thanked her family, friends, coaches, teammates, and school for all their support.

Mayor Flesicher complimented Ms. Widelski on her impresssive performance.

Mayor Fleischer and the Board of Trustees expressed their pride in Ms Widelski's performance and congratulated her on her accomplishments.

Assistant Village Administrator Kirk Zoellner informed the audience that Charleigh recently competed in the National Finals of the MLB Pitch, Hit & Run competition for youth baseball and softball players in Houston, Texas. The competition took place in conjunction with this year's World Series between the Houston Astros and the Philadelphia Phillies.

Charleigh first competed in this MLB-sponsored event at the local level, capturing first place in the 9–10-year-old age category at a July 30 event in South Holland. As a result, she was advanced into a pool with other winners from around the Chicago metropolitan area. The three highest-scoring participants in each age group from all of the local Chicagoland contests were then advanced to the Midwest Regional on August 27 at Guaranteed Rate Field, home of the Chicago White Sox.

Winners of the seventeen regionals held at MLB ballparks throughout the country were next placed into another pool, and participants with the four highest scores were advanced to the National Finals in Houston, site of Games 1 and 2 of the World Series. Out of this process, Charleigh placed in the top 3 in the country for her age group. This resulted in her receiving an all-expenses paid (flight, ground transportation, hotel, food, and attire) trip October 28-30 to attend the World Series and compete for the MLB Pitch, Hit & Run National Championship in her age category.

For the 50 hours she spent in the city of Houston, Charleigh was treated like a big-league ballplayer. Among other things, she received a wardrobe full of World Series and Pitch, Hit & Run attire, attended a Game 1 watch party with MLB executives, participated in a photo shoot and interviews, and watched Game 2 of the Series from complimentary seats in the upper deck behind home plate at Minute Maid Park.

The weekend climaxed on Sunday, October 30, when Charleigh competed alongside 31 of the best baseball/softball players in the nation, ultimately finishing third in her age category.

Charleigh, who at 10 years old is a 5th Grader at St. Mary School in Mokena, is the daughter of Wally and Stacy Widelski. She has a 9-year-old younger sister, Scarlett. The Widelskis have been residents of Mokena since 2019.

A video of Charleigh's participation in the 2022 MLB Pitch Hit & Run competition was presented to the audience.

Trustee Dauphinais congratulated Charleigh on her hard work and accomplishments.

Clerk Martini presented the Community Calendar.

Appointment of Michael McKinney to Maintenance I Worker Position

Assistant Director of Public Works Dan Peloquin advised the Board that as a result of Eric Kelly's resignation, the Street Department had an opening for one (1) Maintenance Worker I position. The Maintenance Worker I position was advertised in July/August 2022 because of previous vacancies, both in a local newspaper and the Village website. Twenty-eighty (28) applicants submitted resumes.

Village staff reviewed the applicants' resumes, conducted initial interviews, and selected five (5) candidates to move on in the interview process. Staff then scheduled second-round interviews with two (2) of the candidates. Based on the results of the interviews, as well as a review of training, work experience, and references, it was determined that Michael McKinney was most qualified to fill the Maintenance Worker I position.

Assistant Director of Public Works Dan Peloquin reviewed Mr. McKinney's work experience and educational background. He further recommended the appointment of Michael McKinney to fill the Maintenance I Worker position as he possesses the skills and capabilities necessary to perform all tasks required in connection with this position.

Trustee Engler made a motion to approve the appointment of Michael McKinney to the position of Maintenance Worker I in the Street Department at the starting step for that position in the First Amendment to the Collective Bargaining Agreement between the Village of Mokena and the International Union of Operating Engineers, Local 150, Public Employees Division, July 1, 2016-June 30, 2020, executed March 22, 2021, effective on approval with an effective start date November 15, 2022. Trustee Metanias seconded.

Trustee Metanias congratulated and welcomed Mr. McKinney to the Village and stated it was nice to see Jamie Smith in attendance for support.
