CALL TO ORDER

Mayor Fleischer called the regular session of the Board of Trustees to order at 7:00 p.m.

Appointment of Jeffrey Ziroli to Community Service Officer Position

Chief of Police Brian Benton stated the Police Department is currently budgeted for four Community Service Officers (CSO). Due to recent resignations, there are currently two CSO vacancies in the Police Department. The Village recently advertised for a part-time CSO through social media and other means and received several resumes. Following the interviews of multiple applicants, it was determined Mr. Jeffrey Ziroli possessed the qualifications to fill the position of Community Service Officer.

Chief Benton discussed Mr. Ziroli's professional background and further recommended the appointment of Mr. Ziroli to the position of part-time Community Service Officer.

Trustee Engler made a motion to approve the appointment of Jeffery Ziroli to the position of Part-Time Community Service Officer at Grade CSO Step 7 effective March 28, 2023. Trustee Metanias seconded.

Hickory Creek Metra Lot Repaying Phase 1 Bid Recommendation

Assistant Public Works Director Dan Peloquin informed the Board that a bid opening was held on March 1 for the Hickory Creek Metra Lot Repaving Phase 1 project. The project consists of repaving just under half of the Metra lot on the easterly side.

Assistant Public Works Director Peloquin advised that ten (10) bids were received for the project, with Gallagher Asphalt of Thornton, Illinois being the lowest bidder. Staff is requesting Board approval up to the Fiscal Year 23 budgeted amount of \$425,000 to allow for additional curb and/or gutter work that may become necessary, additional engineering, and possible replacement of the traffic count detector loop if necessary.

Assistant Public Works Director Peloquin further recommended the contract be awarded to Gallagher Asphalt.

Trustee Engler made a motion to award a contract for the Hickory Creek Metra Repaving Phase 1 project to the lowest bidder, Gallagher Asphalt, of Thornton, Illinois, in the amount of \$394,426.00, and to authorize the expenditure of up to the Fiscal Year 23 budgeted amount of \$425,000 for additional work that may be required at the contract unit prices and for professional fees therein associated, and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.

Therafin Parking Lot Temporary Paving Bid Recommendation

Assistant Public Works Director Dan Peloquin informed the Board that a bid opening was held on March 1 for the Therafin Parking Lot Temporary Paving project. The work will improve drainage, place two inches of temporary asphalt paving, reinstall signage posts, stripe the parking spaces and establish grass everywhere. New lighting and further landscaping are not part of this project. Six required new spaces for those with accessibility needs will be created at the easterly end fronting along McGovney Street.

Assistant Public Works Director Peloquin advised that ten (10) bids were received for the project, with "D" Construction of Coal City, Illinois being the lowest bidder for both the primary bid for two phases of work and the alternative bid for all work in one phase. Staff has recommended completing the project in two phases so that monthly permit commuters at the lot can be moved from phase to phase. The project is unbudgeted for Fiscal Year 23 due to post-budget direction, however the Board has directed staff to pay for this project out of the General Fund.

Assistant Public Works Director Peloquin further recommended the contract be awarded to "D" Construction".

Trustee Engler made a motion to award a contract for the Therafin Parking Lot Temporary Paving project to the lowest bidder, "D" Construction, of Coal City, Illinois, in the amount of \$149,817.50, performed in two phases of work, and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.
