CALL TO ORDER

Mayor Fleischer called the regular session of the Board of Trustees to order at 7:00 p.m.

- c. Motion to approve the placement of an order for one Ford F550 vehicle with uplift from Currie Ford in an amount of \$114,907.24 and to waive the bidding requirement due to inventory shortages and uncertain delivery dates pursuant to 65 ILCS 5/8-9-2.
- d. Motion to approve the North Aquatics Club, Inc. of Tinley Park Bubble Run on Saturday, June 1, 2024; and to authorize the use of municipal/Village resources for event coordination.
- e. Motion to conditionally approve the Mokena Lions Club's 36th Annual Firecracker Dance Weekend and Fundraiser Event on Friday, July 12, 2024 and Saturday, July 13, 2024 utilizing the Front Street commuter lot from Friday morning, July 12 through Monday, July 15, 2024; and to authorize the use of municipal/Village resources for event coordination, contingent upon staff's confirmation and approval of the applicant's final application materials.
- f. Motion to approve the minutes from the February 12, 2024 Board Meeting and Work Session.

Appointment of Brent Cann to Community Development Director Position

Village Administrator John Tomasoski stated that due to the resignation of Matt Ziska on August 1, 2023, there has been a vacancy in the Village's management team for the position of Community Development Director. Since that time, Assistant Village Administrator Greg Anderson has acted as the Community Development Director to keep the department working as efficiently as possible. The opening was advertised on several job sites and our Village website. Over 500 applicants submitted resumes for the Community Development Director position.

Village Administrator Tomasoski discussed the initial review of applicants and interview process conducted by himself, Assistant Village Administrator Greg Anderson and Village Attorney/Human Resources Director Carl Buck. Based the interviews, it was determined that Mr. Brent Cann emerged as the primary candidate and possesses the skills and qualifications necessary to fulfill the duties of the Community Development Director position based on his education, training, and experience.

Village Administrator Tomasoski reviewed Mr. Cann's educational and professional background. He further recommended Mr. Brent Cann to fill the position of Community Development Director.

Trustee Engler made a motion to appoint Mr. Brent Cann to the position of Community Development Director and to approve an employment agreement between the Village of Mokena and Mr. Brent Cann to commence at the direction of the Village Administrator and to authorize the Village Clerk and Village President execute same. Trustee Metanias seconded.

Trustee Metanias welcomed Mr. Cann to the Village.
