Village Attorney/Human Resources Director Carl Buck stated that during its September 9, 2024 and October 21, 2024 work sessions, the Village Board reviewed the proposal and draft ordinance for allowing fishing to be permitted within Village Owned ponds. Based on direction from the Board and in conjunction with input from residents, Staff prepared a proposed ordinance incorporating those regulations.

Village Attorney/Human Resources Director Buck stated the proposed code amendment would be placed within the Public Ways and Property title of the Village Code. There is a penalty provision included which is consistent with the administrative adjudication hearing fine permitted by Illinois law. Village Attorney/Human Resources Director Buck reviewed the following key points included in the draft ordinance:

7-5-1: Public Access Points

- a) The Village shall designate specific public access points to Village-owned ponds, which shall be marked by signage.
- b) Access to Village ponds not designated with public access points shall be restricted to residents of adjacent properties or as otherwise permitted by adjacent residents or Homeowner's Associations.
- c) Any access or trespassing on private property adjacent to ponds without permission is prohibited.

7-5-2: State Fishing License Required

- a) All individuals fishing in Village ponds are required to obtain a valid fishing license from the State of Illinois, as mandated by state law.
- b) For individuals under the age of sixteen (16), at least one parent or guardian must hold a valid state-issued fishing license to ensure compliance with state and local fishing regulations.

7-5-3: Rules of Conduct for Pond Usage

- a) Catch and Release: A catch-and-release policy shall be enforced in all Village ponds to preserve fish populations.
- b) **Hours of Operation**: Fishing is permitted only during daylight hours, specifically from sunrise to sunset, to minimize disturbances to neighboring properties.
- c) **Equipment Restrictions**: The use of only environmentally safe baits and fishing methods shall be allowed. The Village reserves the right to prohibit certain types of fishing gear or bait types to protect pond ecosystems.
- d) Safety Requirements: Swimming, ice fishing, and the use of boats in Village ponds are strictly prohibited.
- e) **Alcohol Prohibition**: The consumption of alcohol is strictly prohibited while fishing on Village-owned or public property.

7-5-4: Environmental Management

- a) The Village, in cooperation with local environmental agencies, may regularly monitor fish populations and water quality in all Village ponds to ensure sustainable fishing practices and overall pond health.
- b) Corrective measures shall be taken if monitoring indicates imbalances or pollution in pond ecosystems.

7-5-5: Violation and Penalty

a) Any person who violates any of the provisions of this Chapter shall be subject to a fine not exceeding seven hundred fifty dollars (\$750.00).

Village Attorney/Human Resources Director Buck stated based on the residents' input and Village Board review, staff are recommending approval of the proposed ordinance.

Trustee Engler made a motion to approve Ordinance Number 2024-O-037, amending the Village of Mokena Code of Ordinances, Title 7, Chapter 5, and to authorize the Village President and Village Clerk to execute the same. Trustee Metanias seconded.

2025-26 Lawn Maintenance Contract Extension Recommendation

Director of Public Works Dan Peloquin stated that in 2022, the Village awarded Beary Landscaping, Inc. the mowing contract for the 2023 and 2024 mowing seasons. That bid and contract allowed the Village to extend Beary's services for up to two additional years upon mutual agreement. This program consists of mowing and maintenance (grass cutting and trimming) of Village-owned properties including the Village Hall, ESDA facility, Village water towers, well sites, pumping stations, wastewater treatment plant, and commuter parking facilities, along with forty-one easements and fifty-five retention ponds and detention basins. The total area in the contract is 178 acres.

Director of Public Works Peloquin stated in the last quarter of the 2024 mowing season, the Village took over landscape maintenance for the newly constructed Police facility and added that site to maintenance sites Beary provided services for. Seasonalizing out that addition work for the full eight month mowing season gives a total cost in 2024 of \$94,475.00. Village staff have discussed with Beary the extension option, with Beary's proposing a mutual agreement to extend the contract with the following proposed cost increases: approximately 3% for 2025 and 2% for 2026 from the total seasonalized cost which includes the Police facility.

Director of Public Works Peloquin stated that based on the Village's ability to extend the contract for the next two years, the desire to utilize continuity of the contractor familiar with the sites, and to continue services at known costs increases, Village staff recommends exercising the Village's right to extend the contract for the 2025-2026 mowing seasons.

Trustee Engler made a motion to award a contract extension for the 2025-2026 Mowing and Maintenance contract to Beary Landscaping, Inc. of Lockport, Illinois in the amount of \$96,975 for 2025, in the amount of \$98,875.00 for 2026, and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.
