Chief Benton reviewed Ms. Carr's educational and professional background. He stated staff believes she is qualified and will prove to be an asset to the Police Department in this position. He further recommended Ms. Carr's appointment to the position of part-time Community Service Officer.

Construction Related Services Agreement for Alta Vista Water Main Extension

Director of Public Works Dan Peloquin stated that in relation to the bid awarded on January 27, 2025 for the Alta Vista Way Water Main Extension project in Fiscal Year 2025, is an agreement for construction related services (CRS) for the project. This agreement with Christopher B. Burke Engineering Ltd. (CBBEL) will provide services to adequately manage and monitor the project and the progress of the contractor. The original design engineering services were also done by CBBEL.

The recommended CRS award amount of \$64,446.00 is nine percent of the average of the nine construction improvement bids by contractors and is below the budgeted amount for such services. This project consists of installation of a new 12-inch diameter water main, along with new valves and fire hydrants, from Owens Road to the rear of the Clarendale of Mokena senior housing facility off Wolf Road. The construction improvements for this project are enabled by a \$500,000 grant from the American Rescue Plan Act of 2021 (ARPA) administered by both the federal government and Will County.

Director of Public Works Dan Peloquin stated it is staff's recommendation that a contract be awarded to Christopher B. Burke Engineering, Ltd. in an amount not to exceed \$64,446.00 to provide engineering construction related services for the Alta Vista Way Water Main Extension.

Trustee Engler made a motion to authorize a Professional Engineering Services Agreement in an amount not to exceed \$64,446.00 between the Village of Mokena and Christopher B. Burke Engineering, Ltd., for construction related services for the Fiscal Year 2025 Alta Vista Way Water Main Extension and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.
