Clerk Martini presented the Community Calendar.

Mayor Fleischer stated it would be a nice gesture for the Village Board to recognize Mr. McClory with a proclamation. He further requested Public Works Director Dan Peloquin follow up with him after looking into Mr. Larke's concerns regarding missing sidewalks.

APPOINTMENTS/PROCLAMATIONS/PRESENTATIONS

Appointment of Gregory Okon to Board of Fire and Police Commission

Mayor Fleischer requested Chief of Police Brian Benton present information regarding the recommended appointment of Gregory Okon to the Board of Fire and Police Commission.

Chief Benton stated the Village of Mokena has a Board of Fire & Police Commission organized under the Illinois Municipal Code, specifically 65 ILCS 5/10-2.1-1, to oversee hiring and disciplinary matters for police and fire personnel. The Code grants the Village President the authority to appoint members to this Board, subject to confirmation by the Village Board. Accordingly, Mayor Fleischer is recommending the appointment of Gregory Okon to the Village of Mokena Board of Fire & Police Commission. Mr. Okon's extensive background in law enforcement, public safety, and community service makes him an ideal candidate to contribute to the effective oversight of the Village's fire and police personnel matters.

Chief Benton reviewed Mr .Okon's professional background and extensive qualifications, stating Mr. Okon's knowledge and leadership skills will be invaluable in fulfilling the Board of Fire & Police Commission's responsibilities, including the recruitment, hiring, and discipline of police officers and firefighters in compliance with state and local laws.

Mayor Fleischer recommended that the Village Board approve the appointment of Gregory Okon to the Village of Mokena Board of Fire & Police Commission.

Trustee Engler made a motion to appoint Gregory Okon to the Board of Fire and Police Commission effective immediately. Trustee Metanias seconded.

<u>Bid Recommendation: Wastewater Treatment Plant and Maintenance Yard Paving Improvements</u>

Public Works Director Dan Peloquin stated a bid opening was held on March 4, 2025 for the Wastewater Treatment Plant and Maintenance Yard Paving Improvements project. This project uses a \$60,000 grant from the Illinois Department of Commerce and Economic Opportunity (DECO). The Village received eight (8) qualified bids, with the lowest bid received was from Advantage Paving Solutions of Frankfort, Illinois, at \$80,232.45.

Public Works Director Peloquin stated after reviewing the bids, it was determined that the bidders were responsive and responsible in accordance with the intent of the bid documents. Further, Advantage Paving satisfactorily performed the Hickory Creek Metra Lot Repaving Phase 2 project last year.

Public Works Director Peloquin stated the project will be completed using Capital Improvement funds and the Department of Commerce and Economic Opportunity

(DECO) grant reimbursement will occur after completion. After the \$60,000 DECO grant is received, the Village will have paid \$20,232.45 for the project.

Public Works Director Peloquin stated the contractor anticipates beginning the work after the asphalt plants open up in early April and recommended the contract be awarded to Advantage Paving Solutions.

Trustee Engler made a motion to award a contract for the Wastewater Treatment Plant and Maintenance Yard Paving Improvements project to the lowest bidder, Advantage Paving Solutions, of Frankfort, Illinois, in the amount of \$80,232.45 and to authorize the Village President and Village Clerk to execute same. Trustee Metanias seconded.

Public Works Department Vehicle Purchase Authorization

Public Works Director Peloquin stated that at the January 27, 2025 work session, the Board supported the purchase vehicles recommended by Staff as part of the FY26 budget. Among those were four Ford F-250 trucks and one F-350 truck. Consistent with the Board's direction, Village staff are seeking to place an order now due to vehicle availability. The process of receiving vehicles can be lengthy and Staff anticipates an extended period of time before the vehicle will be delivered.

Public Works Director Peloquin stated staff contacted Sutton Ford who holds the Suburban Purchase Cooperative (SPC) contract and Currie Ford (the local dealer). He stated that based on the price quotes provided, the extended delivery time, and cost savings, Village staff are requesting approval to waive the bidding process and place the order to purchase four Ford F-250 trucks and one F-350 truck with various snowplow, service box, and liftgate uplift configurations from Currie Ford. Staff confirmed with Currie Ford that placing the order for the vehicles does not commit the Village to purchasing them if the budget is not approved as projected.

Trustee Engler made a motion to approve the placement of an order of four Ford F-250 vehicles and one F-350 vehicle with snowplow, service box, liftgate uplift configurations from Currie Ford as depicted on Invoice No. in an amount of \$364,870.00 and to waive the bidding requirement due to inventory shortages and uncertain delivery dates pursuant to 65 ILCS 5/8-9-2, subject to the approval of the Fiscal Year 2026 Budget. Trustee Metanias seconded.

Trustee Roberts congratulated Liam Kelly and Seth Mendoza on their accomplishments. He recognized Mr. Jim Schlegel for his commitment to the Village and for staying involved with veteran affairs.

Trustee Fedora congratulated Liam Kelly and Seth Mendoza on their accomplishments. She congratulated and thanked Detective McVicker for his efforts. Trustee Fedora encouraged the community to attend the Comprehensive Plan Workshop on April 22 and Clean-Up Day on April 12.
