Garage Permit Requirements

Submit the following information when applying for a Garage Permit:

[] Completed Building Permit Application with signed Homeowners Declaration Rider.
[] One (1) copy of the plat of survey of the property indicating the exact location of the garage and its
setbacks to the sides, rear lot line, and principal structure.
[] One (1) copy of the construction drawings indicating the dimensions of the garage, as well as the sizes
of lumber and a detail of the concrete foundation.
[] One (1) copy of the contract between the property owner & contractor.

- Property owner(s) may give permission for a contractor or any other party to apply for the permit and obtain it, but is still responsible.
- All contractors doing work in the Village of Mokena must be registered with the Village.
- ♦ Upon submittal of the application, survey, and drawings, a review of these documents will be performed.
- Applicant will be notified when the application is approved, and the permit is ready for pickup.

DETACHED GARAGE REQUIREMENTS:

- ◆ SIZE: Cannot exceed 750 square feet in floor area, or 15 feet in height.
- ◆ LOCATIONS: Garages must be located to the rear of the principal structure (house). Garages shall not be located in the exterior side yard of a corner lot. Garages shall not be located in drainage or other utility easements.
- ♦ SETBACK REQUIREMENTS: Setback requirements for garages may be less for smaller lots in the old section of town or greater for larger lots which exceed 100-foot lot frontages. It is the property owner's responsibility to determine the location of lot lines and the proper placement of the garage.
 - o Minimum of 10 feet from the rear and/or side lot line(s) or 10% of lot width, whichever is greater.
 - Minimum of 10 feet from the principal structure (house).
- ◆ All ELECTRICAL outlets must be GFI protected.
- Number: There can be either one (1) attached garage or one (1) detached garage, but not both.
- Driveway cannot be wider than the width of the garage (separate permit required for driveway work).
- OTHER REGULATIONS: These items represent a summary of the most commonly applied regulations pertaining to residential garage installations. Other regulations may apply.

Permit Fees are based on the type of garage, and the number of inspections that may be required.

FIVE (5) INSPECTIONS REQUIRED:

- 1. Footing (*Before* Concrete is poured)
- 2. Rough (framing & electrical)
- 3. Garage floor pre-pour if not monolithic with footing (*Before* Concrete is poured)
- 4. Driveway pre-pour (*Before* Concrete is poured) (under separate permit)
- 5. Final (framing & electrical)
