Exhibitors are responsible for providing their own table or shelving and are responsible for their own wares. 2 chairs will be provided at each booth.

WHERE: In the bright, spacious field house of Lincoln Way East High School, 201 Colorado Avenue, at LaGrange Road (US Route 45), just north of US Route 30, in Frankfort, IL.

NO slides or email websites should be sent. Computer generated photos are acceptable as long as they are clear. Please include your name on the back of each photo. \*\*\*These photos are a requirement of each vear's selection committee, EVEN IF you have previously exhibited at Holli-Daze and will be returned to you on Saturday.

**SASE:** A self-addressed stamped #10 envelope must also be included, so that the club can communicate with you about the show. Any other necessary mailings will be done at the club's expense.

**DOOR PRIZES:** A donation of a craft item(s) for the frequent door prize drawings will be sincerely appreciated. **The winner of each drawing will come to your booth to claim the prize.** This gives the winner an opportunity to see your entire display. Door prize donations are <u>optional</u>.

**RETAIL TAX:** The State of Illinois requires you to report and remit all taxes due based on your total receipts within ten (10) days after the close of the craft show. The current rate is 8%. You, the exhibitor, accepts all liability for federal, state and local taxes related to your sales at the craft show.

**DEADLINE:** Promptness in returning the application is important, but does **not** guarantee acceptance.
