I wish to be considered as an exhibitor, to display and sell my **HAND-CRAFTED ITEMS**, at the 49th annual Holli-Daze Art & Craft Show on **October 26th and 27th** in the field-house at Lincoln-Way East High School in Frankfort, IL. (9:00 AM to 3:00 PM both days).

I realize that this is a show for artisans and crafters, and that imports, buy and sell, white elephant, rummage sale or commercial craft or jewelry items are not allowed in this show. All items must be handmade by you. If we find you are selling commercial craft or jewelry items, you may be asked to leave the show, forfeiting your booth fees, and you will not be allowed to return for future shows. I further understand that if I am accepted into the show, the location of my booth shall be determined by the GFWC Mokena Woman's Club.

****New this year:** space allowing, at our discretion, we may be accepting limited numbers of Multi-Level Marketing (MLM's) Companies, such as Scentsy.

WE REQUIRE at least 2 PHOTOS SHOWING YOUR WORK IN PROGRESS TO ENSURE NO COMMERCIAL ITEMS (please label with your name). *Your application will be returned if photos and envelope are not included.

Set-up times will be 6:15AM – 8:45 AM on Saturday, Oct. 26th. Crafters must exhibit during the full hours on BOTH days. You do not need to break down your display Saturday afternoon.

The Will County Health Department requires a PERMIT for all edibles (dry mixes, candy, cookies, honey, etc.). Contact the department at 708/534-5721. Acquiring this permit is the responsibility of each exhibitor selling anything edible.

No smoking and no alcohol are permitted on the school grounds.

RETAIL TAX: The State of Illinois requires you to report and remit all taxes due based on your total receipts within ten (10) days after the close of the craft show. The current rate is 8%. You, the exhibitor, accepts all liability for federal, state and local taxes related to your sales at the craft show.

CRAFTERS WHO CANCEL AFTER OCTOBER 1 WILL FORFEIT THEIR FEES.
